



## **SSE GUIDANCE FOR NATS DEPARTURE ROUTES CHANGE AT STANSTED**

### **POST IMPLEMENTATION**

#### **INTRODUCTION**

In February 2016, NATS implemented the transfer of Stansted daytime flights from the south-east departure routes (Detling) to the east departure routes (Clacton). This followed earlier approval by the CAA for the proposed airspace change. This has had the effect of doubling the traffic on the Clacton route. Near the airport, more people have suffered an increase in daytime overflights compared with the number of people where daytime overflights have been removed.

While there are winners and losers as a result of this change, SSE opposed the transfer of flights and published information via link

The CAA's airspace change process requires that a post implementation review is carried out by NATS to assess whether the objectives of the change have been realised and whether the anticipated impacts and benefits have been delivered. The review is normally carried out 12 months after implementation to ensure that a full cycle of winter and summer operations has been observed in all weather and traffic conditions.

The sponsor of the change to departure routes is NATS in conjunction with Stansted Airport. The CAA had the responsibility for the approval decision with a requirement to refer its decision to the Secretary of State for Transport in exceptional circumstances.

The post implementation review will take feedback from all stakeholders including local communities and, while the review methodology is currently being consulted upon by the CAA, this guidance outlines actions that residents and local communities can be taking in advance of the formal review.

#### **POST IMPLEMENTATION ACTIONS**

SSE recommends that if residents have been adversely affected by the transfer of departure routes, they should make their views known directly to Stansted Airport using the SSE website form via link <http://sse.rifledesign.co.uk/take-action/report-noisy-aircraft/> Stansted Airport has already stated that complaints about intensification of flights and noise will be forwarded to NATS and the CAA.
